Friendly reminder for those still owing on their taxes, they are due by December 31st, 2022. According to section 5, of bylaw 2022-05-01 Rates of Taxation, any outstanding balance owing on your property tax, as of January 1st, 2023, will incur a 15% Penalty.

While the office is closed, any postmarked or bank payments before January 1, 2023, will be

applied to 2022.

SNOW REMOVALPOLICY - REVIEWED

Council reviewed the Village Snow Removal Policy at the November 14, 2022, meeting. They have decided to maintain the level of service.

What you can expect:

- **1.** Snow removal on Village roads will take place once we have had an accumulation of more than 5cm-10cm or drifting which creates an unsafe driving environment.
- **2.** Complete snow removal of roadways will be done on a priority basis indicated on a map. Drift clean-up, when we have not had 5cm-10cm of accumulation, will be done as needed on a spot treatment basis.

Road Priority Order:

Priority 1 (Orange) - Main Roads, Sidewalks Adjacent to Municipal Properties, Fire Hall Apron, and Municipal Parking Lots. Priority 2 (Blue) – Arterial Roads, Residential Streets.

Priority 3 (Green) – Back Lanes and Ag Society Parking Lot.
